- The speaker(s) that are accepted must be the speaker(s) that presents. Any changes will be considered on a case-by-case basis. A request to substitute must be received in writing no later than August 15, 2025.
- Speakers are not compensated. TAAP does not pay speaker fees, compensate for travel, lodging, or other miscellaneous costs related to presenting a breakout session.
- Selected presenters are offered one complimentary conference registration. Hotel rooms and hotel incidental charges are not included.

Selection Process:

- Submissions are reviewed by the Education Committee and TAAP Executive Leadership team. During the process, we vet the potential speaker and the content, not the speaker's company or organization. There will be no preference given to proposals submitted by exhibitors or sponsors. TAAP expects the speaker to honor their commitment to present the proposed session as presented at the time of acceptance.
- If you have presented at this conference in recent years, we request you offer new material. Preference will be given to presentations that utilize an interactive format with a good deal of participant involvement and provide practical skills training, in an area of specialty practice, especially novel, non-proprietary, measurement-based therapies which represent an advance in the state of the science and art of our profession.

Examples of presentation topics/categories to include, but not limited to:

- Ethics, HIV/HEP C/ STI's, Eating Disorders, Women Veterans and Military Sexual Trauma, Diversity, Equity & Inclusion, Domestic Violence, Sexual Assault, Trauma, Sex and Human Trafficking, Caregiver Burnout, Substance Misuse, Therapy modalities (EMDR, CBT, DBT), LGBTQ+ specific.
- Criminal Justice populations and professionals: topics to include Dynamics of addiction and criminal behavior, The CJ system and processes; Screening, Assessment and Treatment planning for the CJ population; Case management, Counseling in CJ, Trauma of Incarceration.
- Peer Recovery Coaching CEU topics (PRSS) Advocacy; Mentoring/Education; Recovery Support; Ethical Responsibility; Peer Recovery Supervision standards, Benefits of Reciprocity.
- RSPS and MHPS Topics Recovery oriented; Person Centered; Relationship Focused; Trauma- Informed; Recovery and Wellness support; Mentoring; Advocacy; Ethics.

IF YOU ARE SUBMITTING MULTIPLE PROPOSALS YOU MUST FILL OUT SEPARATE FORMS FOR EACH PROPOSAL.

If you are selected – we are requesting all content slides and documents for your presentation be received in full by August 15, 2025 so they may be uploaded to the conference app. If you do not provide them by this date, they may not be include in the application portal for participant access. Apply the 666 rule to power point/keynote slides: six words a line, six lines per slide and no more than six slides of text before using a graphic. At most! While this is not a hard-and-fast rule, it provides basic guidance for a concise and easily visible presentation in large rooms or audiences.
